DBS Trustee is a wholly-owned subsidiary of DBS Bank Ltd. ("DBS Bank") which is a wholly owned subsidiary of DBS Group Holdings Ltd ("DBS"). DBS Bank also holds 1.733% of the units of NetLink Trust. Temasek has a more than 20% interest in DBS. Therefore, Temasek is deemed to have an interest in all of the shares of NetLink Management held by DBS

pursuant to the TM Share Trust. Singtel Interactive has a direct and deemed interest in 24.99% of the units of NetLink Trust.
